

Continuous Legal and Institutional Challenges Related to Internet Posts

- Issues such as the limited real-name verification system and interim measures have raised concerns over freedom of expression for users.
- Increased public concern about users' responsibility for malicious comments and defamatory posts.
- The absence of clear standards after implementing interim measures has added technical and social burdens to internet service providers and intensified user confusion.

Proactive Self-regulation Initiatives

in Other Countries

- Other nations actively promote self-regulation and adopt coregulation models that reflect their social, cultural, and political environments.
- Governance being established to address issues such as harmful content targeting youth and privacy protection.
- The UN emphasizing freedom of expression on internet as a fundamental right, which has led to a reduction in governmental regulations globally.



Key Functions of KISO

Key Functions

- Support for self-regulation of posts by member companies through policy-making/deliberation decisions

Articles of Association Article 4. (Key Functions)

- Establishment of instrument code and guidelines
- Managing issues concerning policies related to Internet posts requested by members, etc
- Exchange and cooperation with international self-regulatory organizations and participation in activities of international organizations
- Publishing of books or periodicals related to self-regulatory activities on the Internet
- ✤ Other businesses that serve the purpose of the organization
- ✤ Other profitable businesses that serve the purpose of the organization

Policy Committee



Key Functions

- Support policy decisions and deliberation decisions
 - > Enactment and amendment of policy regulations
 - Decision on the agenda requested by the subcommittee/subcommittee
 - Establishment, abolition, and composition of subcommittees
 - Matters concerning the publication of policies and reports, etc

Making Decisions

- Policy Decision: Unanimous System (should be proposed by subcommittee after consultation)
- Decision on deliberation: Majority vote (2/3 of the registered members)
- A decision is made after a sufficient deliberation process

× If necessary, social opinions would be gathered by holding seminars or etc.

(If a fast action is required, a quick decision can be made)

Purpose

KISO reviews whether to apply temporary measures, re-post permissions, or delete related search terms based on member company proposals (Article 30 of the KISO Policy).

Role

- Provides shared solutions for individual cases and supports member companies.
- Offers interpretative criteria for KISO policy regulations (e.g., defining the scope of public figures, evidence requirements for false claims).

Provision of standards for handling self-regulation, such as provisional measures system

Significance

- Offers judgment criteria for businesses when addressing similar cases → Significantly influences the handling of similar posts by businesses
- Systematization of the Temporary Measures System (Article 44-2 of the Telecommunications Network Act)

KISO Subcommittee Structure



- Expanding Self-regulation in IT Services
- Subcommittees flexibly apply policies according to member companies' needs.

User Content Subcommittee

Establish policies on posts and search terms generated by users and deliberate on specific issues

(Performs policy making and deliberation function related to posts and search terms of previous policy committee)

 \bigcirc Responding to issues such as hate speech

Subcommittee on Posting and Search Word Policy

- ▶ Key functions: Developing policies related to posts and search terms, Deliberation.
- Major Activities
 - Responding to policies related to temporary measures concerning posts such as defamation and infringement of rights, etc
 - Review of related and automatic completion search term policies

Hate Speech Review Committee

- ▶ Key functions : Developing policies related to hate speech, Deliberation
- Major Activities
 - Specification of policy regulations to mitigate discriminatory expressions
 - Implementation of Guidelines for Self-regulation Policy for Hate Speech
 - Deliberation on hate speech and recommendation of measures

Service Operation Subcommittee



Consultation and deliberation on specific services provided by member companies
 Support member companies' self-regulation by making policies through accumulating cases of deliberation and consultation on various IT services

Service Operation Subcommittee

► Key Functions: Review and consultation on the legality and social feasibility of a member company's services

(if necessary) establish self-regulatory standards through consultation between similar service providers

Major Activities: Operation of Person Information Service Guidelines (currently being used as a standard for Naver and Kakao operations)

Online Advertising Subcommittee



○ Perform autonomous regulations for online real estate advertising

- Implementation of online real estate advertising autonomous regulations
- Various real estate policies related to advertisements
- Verification of real estate sales and management of false sales reports

Real Estate Advertisement Subcommittee

- ► Key Functions: Making policies related for fairness in online real estate advertising and deliberation
- ► Major Activities
 - Establishment of relevant standards, such as self-regulation and guidelines for online real estate advertisements
 - Protection of consumer rights and interests by investigation of violations of real estate advertisements and corrective measures, etc
 - Major domestic real estate information service providers such as Naver Pay Real Estate, Kakao, Dabang, KB Real Estate, and Maekyung Real Estate join the self-regulation by joining as participants

Technology Subcommittee



- \bigcirc Self-regulation related to new IT technologies such as AI, algorithms, etc
- Realizing social responsibility by integrating DB provided by member companies and providing DB for technical protection measures

Subcommittee on DB Self-Regulation


- ▶ Key functions: Establish policies on abusive language, youth protection search terms, etc. and share and utilize DB among member companies
- Major Activities:
 - Deliver timely DB through real-time API data delivery
 - Reduce the risk of member companies by preparing relevant standards
 - Distribution of KISO Anti-Cursive System (KSS / KISO Safeguard System)
 - Using KISO's abusive integrated DB, provide the requestor with the corresponding DB in API format
 - Establishment of a search term DB for youth protection (implementation of search term

guidelines for youth protection)

New Technology Subcommittee

- ► Key functions: Research on policies for various new technologies such as artificial intelligence (AI)
- ► Major Activities: Implementation of Chatbot Ethics Guidelines
